The Annual Meeting of the Alumni Association of Randolph-Macon Academy was held on the Academy's Front Royal, Virginia Campus on the Twenty-Second of October, Two-Thousand Twenty-Two. The President being in the Chair, and the Secretary being present, the meeting was called to order at Forty-Five Minutes past Noon.

The President welcomed the Alumni and their guests and introduced the Officers and Members-At-Large of the Board of Directors of the Association.
